No.1 Scholarship Recipient agrees to receive scholarship for theDegree which will start to receive fromSemester in Academic YearScholarship will be paid into 2 installments Scholarship recipient in Social Science Field will be paid 23,000 THB per installment and Scholarship recipient in Science Field will be paid 31,000 THB per installment.

No.2 Scholarship Recipient must act as teacher assistant from the 1st semester in Faculty/College/Department or Program that he/she is studying for 6 hours per week.

No.3 Scholarship Recipient must send Teaching Assistant Duty Report signed by teacher to Graduate School every the end of the month

No. 4 Scholarship Recipient must send Study Report and Thesis Progress Report with the agreement of thesis advisor to Graduate School every the end of semester and also present the study plan every the beginning of the semester. Scholarship will be paid after the agreement of Scholarship Giver. In the case that Scholarship Recipient’s GPAX is lower than 3.25 in two consecutive semesters or receives “U” in any repeat course consecutively, Scholarship Giver has the right to stop and cancel the scholarship.

No.5 In the case that Scholarship Recipient stops or has an education leave without appropriate reasons or does dishonest actions and plagiarism, Scholarship Giver has the right to ask for the restitution of all money.

No.6 Scholarship Giver has the right to terminate this contract if Scholarship Recipient misconducts in any of the above conditions and Scholarship Recipient has to return all money. In the case that Scholarship Recipient does not disburse in the given period, Scholarship Giver will charge interest rate of 7% per year or in the consideration of Scholarship Giver.
